

Is my water safe?

Yes it is. Last year, as in years past, your tap water met all U.S. Environmental Protection Agency (EPA) and State drinking water health standards. The Department of Water Supply vigilantly safeguards its water supplies and once again we are proud to report that your system has complied with all drinking water standards.

Why are there contaminants

in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Source Water Assessment Program

In 2004, the preliminary source water assessment report was released. The purpose of the source water assessment report is to enable the public and decision-makers to make well-founded decisions for the protection and preservation of our drinking water. The source water assessment report identifies the potential contaminating activities for each source of water.

In the report, Pepeekeo Water System sources are potentially vulnerable to contaminants associated with the following activities: recorded spills, cesspools, sugarcane, roads, sewer lines, and residential parcel. Simazine, atrazine, and dieldrin have been detected in the water which is attributed to runoff from herbicides and insecticides used on crops. 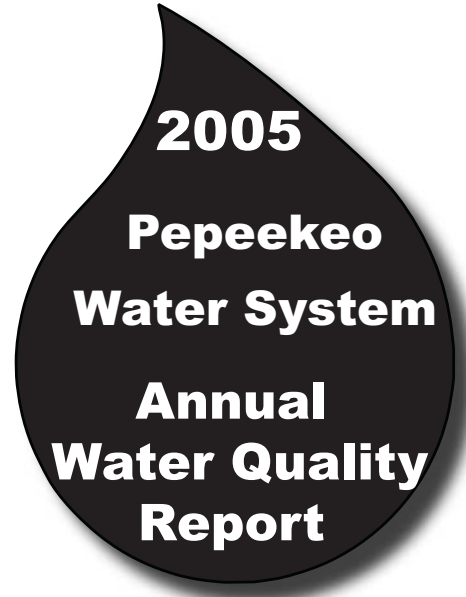

Sodium in drinking water

There is no State or Federal maximum contaminant level for sodium. Although required, monitoring for sodium is performed primarily to gather information for the consumers, the Safe Drinking Water Branch, and the Department of Water Supply. The EPA Drinking Water Advisory recommends that the sodium concentration in drinking water not exceed a range of 30 to 60 mg/L because of the possible adverse effects on taste at higher concentrations.

For persons on a sodium-restricted diet, sodium concentrations greater than 120 mg/L could be problematic. If you are on a sodium-restricted diet, you should consult your physician about the level of sodium in the drinking water.

Sources of drinking water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the

Key definitions of terms used in this report

- MCLG** = Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk for health. MCLGs allow for a margin of safety.
- MCL** = Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology
- AL** = Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- ppm** = Parts per million. One ppm corresponds to a single penny in \$10,000 or about one minute in two years.
- ppb** = Parts per billion. One ppb corresponds to a single penny in \$10,000,000 or about one minute in two thousand years.
- ND** = Not Detected: If a contaminant is not measured at or above its minimum detection limit, it is reported as Not Detected - detection limits are available upon request.
- n/a** = not applicable

surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
 - Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
 - Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
 - Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
 - Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.
- In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Where does my water come from?

The present source of water for the Pepeekeo Water System is Kulaimano Well, which is a groundwater source. The use of Maukaloa Spring, which is a groundwater source, was discontinued in October of 2004. The source(s) of supply may change depending on the supply and demand. In previous years we have included a map of the distribution system. However, because we are taking measures to safeguard your water supply, we are not including the map in this year's water quality report. Thank you for your understanding.
