# WATER BOARD, COUNTY OF HAWAI'I NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Water Board of the County of Hawaii will hold public hearings on the Proposed Water Rates at **5:00 p.m., Tuesday, May 26, 2015**, at the West Hawaii Civic Center, Building G, Community Hale, 74-5044 Ane Keohokalole Hwy, Kailua-Kona, and at **6:00 p.m., Wednesday, May 27, 2015**, at the Liquor Control Conference Room, Hilo Lagoon, Lobby Level, 101 Aupuni Street, Hilo.

Pursuant to Chapter 54, Part III, Hawaii Revised Statutes, the hearings will be for the purpose of hearing views and comments of all persons interested in the following proposals for increases in the water rate schedules to be applied by the Department of Water Supply, County of Hawaii, for all districts.

Not all components of the Department's water rate structure are subject to change at this time. Those components remaining unchanged include: General Use Block Thresholds, Agricultural Use Block Thresholds, Power Cost Charges, Service Lateral Installation Charges, Facilities Charges, and Temporary Service on Hydrant Charges.
