INVITATION FOR BIDS FOR THE KA'AUHUHU #2 BOOSTERS A, B & C REPAIR DISTRICT OF NORTH KOHALA County of Hawai'i – State of Hawai'i

The following revisions and changes shall be made a part of the contract bidding documents:

1. Changes to **PROPOSAL:**

- a. <u>**DELETE</u>** Proposal section its entirety and <u>**REPLACE**</u> with the attached replacement Proposal Section.</u>
 - i. Revisions have been made to the following pages:
 - (1) Page P-9, replaced with page P-9A, revises Part "C" (Materials & Services), Item No. 8. Booster assembly vibration peak velocity of 0.05 ips has been increased to 0.156 ips.
 - (2) Page P-10, replaced with page P-10A, revises Part "D" (Electrical Work), Item No. 3. Change includes the addition of a third heavy duty safety switch for booster C and the revision of the specified switch amperage rating for all three heavy duty safety switches.

2. Changes to **SPECIAL PROVISIONS:**

a. <u>**REVISE**</u> Page SP-10, Section 304.03 A.3.c., the existing language for this item shall be deleted in its entirety and replaced with the following:

"Installation of three (3) NEMA 3R painted steel heavy duty safety switches, conduit, and new wire to provide power to three (3) motors for Boosters A, B & C, inclusive of mounting hardware. Safety switches shall be wall mounted or supported by galvanized steel Unistrut mounting structures with stainless steel fasteners at the option of the Contractor.

- b. <u>**REVISE**</u> Page SP-35, Section 304.05 A.4.h., booster assembly vibration peak velocity of 0.05 ips shall be increased to 0.156 ips.
- c. <u>**REVISE**</u> Page SP-43, Section 304.05 B.7.d., Krohne model Waterflux 3070 C flow meter body material shall be changed from stainless steel to *coated carbon steel*.

"The Contractor shall repair the boosters in sequence and complete a satisfactory efficiency test before starting on the repair of the next booster. Booster C shall be the first booster repaired with boosters A & B repair sequence to be coordinated with DWS personnel. Prior to taking any booster offline, all materials required to replace the booster shall be onsite or staged at the Contractors baseyard to minimize downtime."
