NOTICE IS HEREBY GIVEN that the Water Board of the County of Hawai'i will hold a public hearing on **May 25, 2021, at 9:45 a.m.**, for the purpose of considering and adopting a new cost of Power Adjustment Clause, pursuant to Hawai'i Revised Statutes Chapter 54, Part III, as amended. The public hearing will be held via web conferencing; Host Location: 345 Kekūanaō'a Street, #20, Hilo, Hawai'i. RATE CHANGE: POWER COST CHARGE

The current Power Cost Charge of \$1.71 per thousand gallons is under consideration for a possible increase to reflect increased power costs from all power sources. The proposed Power Cost Charge will be **at a rate of \$1.85**. The approved rate will be effective the first day of the month after the establishment of the rate by the Water Board.
