## WATER BOARD, COUNTY OF HAWAI'I <u>NOTICE OF PUBLIC HEARING</u>

NOTICE IS HEREBY GIVEN that the Water Board of the County of Hawai'i will hold a public hearing on **February 22, 2022, at 9:45 a.m.**, for the purpose of considering and adopting a new cost of Power Adjustment Clause, pursuant to Hawai'i Revised Statutes Chapter 54, Part III, as amended. The public hearing will be held via web conferencing; Host Location: 345 Kekūanaō'a Street, #20, Hilo, Hawai'i. ## **RATE CHANGE: POWER COST CHARGE**

The current Power Cost Charge of \$2.15 per thousand gallons is under consideration for a possible decrease to reflect decreased power costs from all power sources. The proposed Power Cost Charge will be **at a rate of \$2.02.** The approved rate will be effective the first day of the month after the establishment of the rate by the Water Board.
