

NOTICE TO BIDDERS
(Chapter 103D, HRS)

SEALED BIDS for **JOB NO. 2022-1205, PALANI DEEPWELL A REPAIR**, District of North Kona, County of Hawai‘i, State of Hawai‘i, will be received ELECTRONICALLY by the Department of Water Supply, County of Hawai‘i, until **January 12, 2023 at 2:30 p.m.** when they will be publicly opened and read aloud. Bids received after the time fixed for opening or delivered elsewhere other than specified herein will not be considered.

This project generally consists of furnishing all labor, materials, tools and equipment necessary to remove the existing pump, motor, and column assembly; install new submersible pump, slim-line motor, column assembly, power cable, sounding tubes, and all appurtenant materials; chlorination of the well and pumping assembly; daily clean-up of the job site at the conclusion of each work day; complete an efficiency test; and perform all incidental work necessary to complete repair in accordance with the specifications

A pre-bid meeting shall be scheduled for **December 19, 2022, at 10:00 a.m.** at the Department of Water Supply’s Hilo Baseyard located at 889 Leilani Street, Hilo, HI, 96720. Site visits shall be by request only, contact project engineer to schedule visit and for directions.

To be eligible to submit a bid, the Bidder, or subcontractor, must possess a valid State of Hawai‘i C-57a or C-68 Contractor’s license.

Upon registration, forms of specifications, instructions, terms and conditions, and proposal may be obtained from the Office of the Manager-Chief Engineer, through PUBLIC PURCHASE (www.publicpurchase.com), an e-procurement system.

Prospective bidders must file with the Manager-Chief Engineer their "Intent to Bid" no later than ten (10) calendar days prior to the time advertised for opening of bids.

The original executed and notarized Standard Qualification Questionnaire for Offerors form ("SQQ") provided by the Department of Water Supply is required to be filed with the Manager-Chief Engineer for evaluation no later than eight (8) days prior to the time advertised for the opening of bids unless the bidder has previously filed a Questionnaire within the previous two (2) years of the date of opening of bids.
