

**NOTICE TO BIDDERS**

SEALED BIDS for **WATER TREATMENT PROPOSAL NO. 2024-05, FURNISHING AND DELIVERING COAGULANTS TO THE WAIMEA WATER TREATMENT PLANT**, District of South Kohala, County of Hawai'i, State of Hawai'i, *on an as-needed basis*, for a contract period starting **July 1, 2024, to June 30, 2026**, will be received ELECTRONICALLY by the Department of Water Supply, County of Hawai'i, until **May 2, 2024, at 1:30 p.m.** Bids received or delivered elsewhere other than specified herein will not be considered.

The project consists of paying for all labor, materials, transportation, tools, taxes, and equipment necessary for the furnishing and delivering of coagulant to Waimea Water Treatment Plant (on an as-needed basis), District of South Kohala, for the Department of Water Supply, County of Hawai'i, State of Hawai'i.

**Upon registration, forms of specifications, instructions, terms and conditions, and proposal may be obtained from the Office of the Manager-Chief Engineer, through PUBLIC PURCHASE ([www.publicpurchase.com](http://www.publicpurchase.com)), an e-procurement system.**

The bidder's attention is directed to the following:

Bidders that wish to qualify a coagulant for this bid that is not listed on the pre-qualified coagulant list shall submit an adequate sample of the coagulant and its specifications for testing and approval. Sample will be used in a jar test to confirm its compatibility with the raw water at the WWTP. Bidder shall contact Mr. William O'Neil, Waimea Water Service District Supervisor at (808) 887-3030, to coordinate delivery of sample and specifications. Samples and specifications shall be delivered to 65-1234 Opelo Road, Kamuela, Hawai'i, 96743. Bidders may also be present to witness their sample jar test. Samples and specifications for testing **MUST be received by April 11, 2024**, three (3) weeks prior to the date scheduled for the opening of bids.

The Department of Water Supply reserves the right to reject any and/or all bids, and to waive informalities.
